(I) one (1) position for a Researcher A' or B' tier, in the area of “User Modeling, Recommender Systems, Personalization”

(II) one (1) position for a Researcher A' or B' tier, in the area of “Big Data Flow Processing”

1. Candidates for these positions should fulfill the following:
 - a. Have the qualifications of a Researcher A' or B' tier, as these are specified in Law 4310/2014, as applicable
 - b. Hold a PhD degree, with experience in
 - “User Modeling, Recommender Systems, Personalization” for position (I)
 - “Big Data Flow Processing” for position (II)
 - c. Be Greek citizens or citizens of other EU Member States

- d. Have proficient knowledge of the English language. For citizens of other EU Member States, adequate knowledge of the Greek language is required, as evidenced by Attainment Certificate of Greek Language Centre or by an equivalent Certificate issued by the School of Modern Greek Language of the Aristotle University of Thessaloniki or of the Modern Greek Language Teaching Centre of the National and Kapodistrian University of Athens or any equivalent Certificate issued by an Institute outside of Greece
2. Interested individuals are invited to submit their application, which takes the place of Statutory Declaration of Article 8 of Law 1599/1986, in person or by an authorized person or via registered mail to the Secretariat of IMIS / R.C. ATHENA, Artemidos 6 & Epidavrou, Postcode 15125, Maroussi, Athens, Greece, until 24-02-2016. Along with the application, absolutely necessary documents to be submitted are:
 1. Copies of all degrees (Bachelor's degree, PhD etc.), which in case of appointment should also be submitted in certified form. For degrees awarded abroad, candidates are required to submit a certificate of approval from the Hellenic National Academic Recognition Information Center (Hellenic NARIC) when submitting the application or alternatively upon appointment
 2. CV in six (6) copies, which will include information concerning the educational background of the candidate as well as an extensive analysis of his or her scientific activities along with two (2) copies of their scientific publications
 3. Certificates that validate any previous experience in equivalent positions
 4. Three (3) names of researchers/professors (full address and email address) from whom recommendation letters may be asked
 5. A photocopy of both sides of the ID card (for citizens of EU member states, a certificate from the respective authority of the state of the candidate's citizenship)

Health and physical fitness Certificate from a Primary Health Committee, birth certificate, criminal record for judicial use and Form A military status certificate will be requested by the successful candidate before the appointment.
