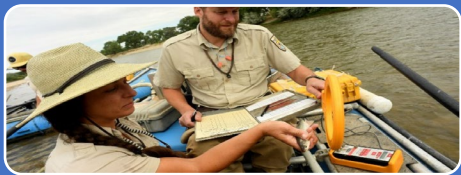

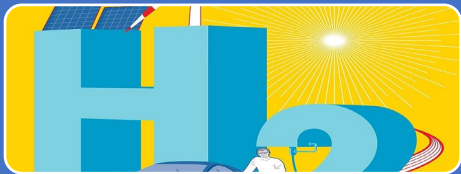

ERA Policy Action

1

Enable the open sharing of Knowledge and the re-use of research outputs, including through the development of the European Science Cloud (EOSC)



Adoption and implementation of the National Plan for Open Science, a cohesive and intertwined framework of policy, technology, networking, and community-building activities to establish OS as the 'new normal'

- Integrate **OS practices** across *all* national research funding programs launched by GSRI (*evaluation, implementation*), starting from the end of 2023
- Establish **national OS e-Infrastructure**, ensuring its further development, scaling, democratization, and sustainable operation until 2033
- Establish a bottom-up, open, and **collaborative initiative** of science-performing organizations and civic initiatives as the officially mandated **consulting organization** of the Greek government for formulation/ update of the Strategy, monitoring & evaluation of OS adoption, democratization and wide-spread of OS in Greece, identification & dissemination of OS best practices, participation in EOSC events and organization of national OS events
- Support RIs included in the **revised National Roadmap 2021-27** to ensure their inclusive participation and connection to EOSC and the provision of their services, tools, and data.

ERA Policy Action 4

Promote attractive and sustainable research careers, balanced talent circulation and international, transdisciplinary and inter-sectoral mobility across the ERA



- Exchange of best practices on **skills, inter-sectoral mobility,** and initiatives aiming at **more balanced talent circulation**
- Support the national **EURAXESS** Bridgehead Organisation (BHO) to actively work on co-designing and co-developing the **ERA Talent Platform**
- Provide **information/data on researchers' flows** (jobs, skills, working conditions, mobility) through EUROSTAT, complemented by OECD and Commission surveys, in the context of the **Observatory on Research Careers**
- **Raise awareness** about how mobility might affect pension rights, and exploring the possibility and necessary reforms in order to participate to RESAVER
- Provide funding at national level for training projects, courses, programmes, staff exchanges, or other initiatives contributing to **research upskilling, inter-sectoral mobility, interoperability of careers, researcher entrepreneurship.**

ERA Policy Action 10 Make EU Missions and Partnerships key contributors to ERA

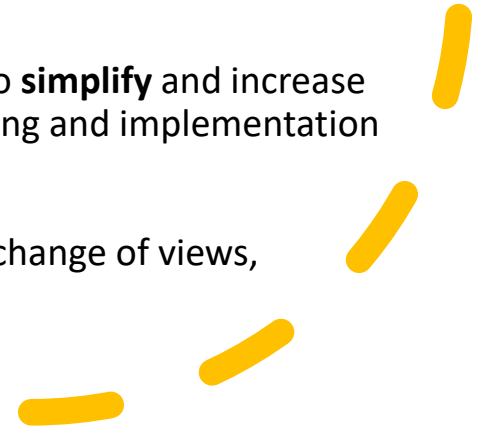


For Missions

- Promotion of **synergies** with national programmes and initiatives, particularly in the framework of the National Smart Specialisation Strategy for Research and Innovation (RIS3)
- Raising **awareness** and promotion of dialogue at national level
- Participation to the **MLE** for the implementation of Missions
- Appointment of **high-level national experts** to the Mission working groups; exchange of views, enhanced dialogue and coordination.

For Partnerships

- Enable **synergies** and intensify links with national programs and activities
- Increase **awareness** and promote involvement of thematic policy areas and government structures, agencies and ministries
- Elaborate and promote measures at national level aiming to **simplify** and increase the effectiveness of **national procedures** followed for funding and implementation of the projects co-funded through the Partnerships
- Active participation to the **Partnership Knowledge Hub**, exchange of views, information and best practices.



ERA Policy Action 11.1 ERA for Green Transformation: Green Hydrogen



Greece participated to the preparation of the **Green Hydrogen Strategic Research & Innovation Agenda** and the relevant events. Greece will:

- ✓ Contribute to a new **Implementation Working Group**
- ✓ Contribute to:
 - The joint development of a **Clean Hydrogen Observatory**
 - The improvements of **education and skills**, based on the priorities of the National Smart Specialization Strategy and the Just Transition Plan, developing curricula and trainings for the most relevant jobs in hydrogen
 - The acceleration of the **pre-market step** of the hydrogen value chain through completing the holes in testing infrastructures for hydrogen technologies (e.g. call on Open Innovation Test Beds for hydrogen)
 - The Expansion the European landscape of **Hydrogen Valleys** through regional, national, joint European initiatives

- **Mobilizing young people** and providing support for sampling and analysis of plastic pollution in sea, coastal zone and inland waters in several sites around Greece.
- **Organizing awareness-raising events**, in order to bring scientific research for a clean and healthy environment closer to the citizens and to adopt environmental-friendly behaviours.

- The **University of the Aegean** (Department of Marine Sciences)
