

Call for Applications:

Three (3) external member positions for the Executive Board of the Hellenic Pasteur Institute (HPI).

1. We announce the filling of three (3) positions of external members of the Executive Board of the Hellenic Pasteur Institute (HPI), as follows:

A. Two (2) positions of scientists with international prestige, administrative experience and research and technological activity, related to at least one of the objects of the Institute. They must have the qualifications to be appointed to the position of A-level researcher or equivalent university professor.

The researchers are scientists with high scientific experience and training, holders of a PhD.

The qualifications of the A' level researcher are:

Proven ability to develop research and its applications in new areas, to coordinate activities in wider fields of research and technological development, to contribute to the formulation of research and technology policy and the development of research organizations by attracting external funding, to be internationally recognized for his/her contribution to scientific and technological fields of his specialty, to have contributed to the dissemination and application of the knowledge produced by the research, to have a rich written work in monographs or publications in internationally recognized journals or important patents and to have been recognized by other researchers for his contribution to the progress of science and technology.

The qualifications of the A level Professor are:

i) Six (6) years at least:

independent teaching, after obtaining a PhD in the subject of the Field, with a documented contribution to the formation and teaching of the material of at least two courses or work in recognized research centers of the country or abroad or a recognized professional project in a relevant scientific field.

The time period of six (6) years can be allocated in combination to the above activities, which in any case are corresponding to the scientific level and related to the knowledge field of the advertised position.

ii) Original publications in scientific journals of recognized prestige, of which a number must be independent or original scientific monographs, excluding self-published works.

iii) Postgraduate teaching experience recommended by teaching for three years, at least, in Higher Education Institutes Postgraduate Studies Programs. of the country or abroad, or supervision, in the capacity of supervisor, of at least one doctoral thesis that has been successfully completed, from the beginning to its completion, or participation in three-member advisory committees of at least two doctoral theses that have successfully completed, from the beginning until their termination or management for at least three years of recognized Research

Institutes or at least a three-year term in a managerial position of International or European Organizations.

In addition, it is taken into account whether the overall research project of the candidate has been recognized by the scientific community.

B. One (1) scientist position, with wide experience in economics, industry or administration.

2. The said members of the Executive Board are entitled to compensation for their participation in the meetings, in accordance with the provisions of article 22 of Law 4354/2015. The term of office of the members of the Executive Board is four years (4 years). Each member of the Executive Board may serve up to two (2) terms.

3. The following supporting documents are required for the appointment:

I. Birth certificate. For citizens of member states of the European Union, a certificate from the competent authority of the state of which the candidate has citizenship.

II. For males, certificate of military status. The obstacle of military obligations does not apply to citizens of a member state of the European Union, in which no similar obstacle of appointment is provided.

III. Copy of criminal record for judicial use.

The above supporting documents are not submitted by the interested parties, but will be sought ex officio by the General Secretariat for Research and Innovation based on the provisions of articles 5 of Law 3242/2004 (Government Gazette: A'102) and 16 of Law 3448/ 2006 (Government Gazette: A'57) in the context of issuing the final act of appointment.

4. Candidates must submit:

In printed form:

- Application (handwritten or typed) in which the interested party will request that his/her candidacy be accepted and will state the accompanying supporting documents.
- Responsible declaration of Law 1599/1986, in which the following will be declared (with knowledge of the sanctions provided by the provisions of par. 6 of article 22 of Law 1599/1986): citizenship of an EU member state, certificate of military completion obligations, clean criminal record, accuracy of all submitted data.
- Photocopy of police ID.
- Copies of national or foreign degrees (in duplicate). In the case of qualifications from foreign institutions, candidates are required to present (in duplicate) a certificate of recognition from DOATAP – Hellenic National Academic Recognition and Information Center (formerly DIKATSA).
- Detailed curriculum vitae, in Greek (in duplicate)
- Detailed curriculum vitae, in English (in duplicate)

In electronic form (on 2 usb stick storage devices):

- Detailed curriculum vitae, in Greek.
- Detailed curriculum vitae, in English.
- Copies of publications.
